The appointment of directors will be formally approved through a resolution at the 25th Ordinary General Meeting of Shareholders scheduled to be held on June 24, 2025.

1. Purpose of Transition to New Management Structure

To All Concerned Parties

The Company formulated a five-year Medium-Term Management Plan ending in the fiscal year ending March 31, 2027 and has been working to expand earnings. In the meantime, the business environment has changed rapidly and a review of management policies and business strategies became an urgent management issue.

Under these circumstances, the Company will restructure its business portfolio on the business front and work to further strengthen corporate governance and accelerate management decision-making on the organizational front.
